C. Amendment to Bylaws

Dr. Chris Franklin presented the following amendment to the bylaws for adoption:

Members of the Commission on Administration, Commissions on Faculty, Commission on Students, Commission on Support Personnel, and Commission on Workforce Development will elect a Vice-Chair/Chair-Elect for each Commission at the annual conference. The Vice-Chairs/Chair-Elects will be elected by majority of the votes cast by the members in attendance at the conference's commission meetings. The Commission Vice-Chairs/Chair-Elect will assume office at the adjournment of the annual conference. The sitting Vice-Chair/Chair-Elect will automatically succeed to the position of Commission Chair following the conclusion of his or her term as Vice-Chair/Chair-Elect. The Commission Chairs will assume office at the adjournment of the annual conference.

A motion to accept the amendment was made by Dr. Kevin Windham and a second by Ms. Trish Jones. The motion passed.

D. Introduction of Incoming President

Mr. Jordan introduced Ashli Wilkins as the incoming ACCA President. Dr. Wilkins was unable to attend, so Second Vice President Annette Funderburk made remarks in her stead.
